Definitions

- "Number of Students Who Began the Program" means the number of students who began a program who were scheduled to complete the program within 100% of the published program length within the reporting calendar year and excludes all students who cancelled during the cancellation period.
- "Students Available for Graduation" is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.
- "Number of On-time Graduates" is the number of students who completed the program within 100% of the published program length within the reporting calendar year.
- "On-time Completion Rate" is the number of on-time graduates divided by the number of students available for graduation.
- "Graduates Available for Employment" means the number of graduates minus the number of graduates unavailable for employment.
- "Graduates Unavailable for Employment" means the graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.
- "Graduates Employed in the Field" means graduates who beginning within six months after a student completes the applicable educational program are gainfully employed, whose employment has been reported, and for whom the institution has documented verification of employment. For occupations for which the state requires passing an examination, the six months period begins after the announcement of the examination results for the first examination available after a student completes an applicable educational program.
- "Placement Rate Employed in the Field" is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.
- "Number of Graduates Taking Exam" is the number of graduates who took the first available exam in the reported calendar year.
- "First Available Exam Date" is the date for the first available exam after a student completed a program.

STUDENT'S RIGHT TO CANCEL

You have the right to cancel your enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh calendar day after enrollment, whichever is later.

To cancel, you must give written notice of cancellation to ZMS The Academy at 2228 E. Cesar E. Chavez Ave., Los Angeles, CA 90033, or by email to zmsacademy@gmail.com. The notice need not take any particular form; it is effective if it states that you no longer wish to be bound by the enrollment agreement. Cancellation is effective on the date the written notice is delivered or, if mailed, on the postmark date.

If you cancel within this period, the school will refund all money paid, less the non-refundable registration fee (not to exceed \$250) and the Student Tuition Recovery Fund assessment, within 45 days of receiving your notice of cancellation.

If you withdraw after the cancellation period and before completing 60% of the scheduled clock hours in the current payment period, you are entitled to a pro rata refund of tuition for the portion of the program not attended, calculated as tuition charged divided by the total scheduled clock hours multiplied by the number of scheduled clock hours not attended. No tuition refund is due after 60% of the scheduled clock hours have been completed. Refunds are paid within 45 days of the date of withdrawal or the date the school determines you have withdrawn.

If you received federal student financial aid funds, you are entitled to a refund of moneys not paid from federal student financial aid program funds.
